- 2. प्लास्टिक लाईनिंग शीट पंजीयन प्रक्रिया वित्तीय वर्ष 2023–24 से 2025–26 (तीन वर्ष) तक मान्य रहेगी।
- 3. इच्छुक निर्माता / कम्पनियों द्वारा आवेदन ऑनलाईन किया जाएगा एवं आवेदन शुल्क राशि रू.1000 / – (एक हजार मात्र) राज किसान साथी पोर्टल पर ऑन लाईन आवेदन के समय पर जमा करवाया जाएगा।
- 4. आवेदक समस्त प्रकार से पंजीयन हेतु पात्र पाए जाने पर आयुक्त कृषि के अनुमोदन उपरान्त ऑनलाईन ही राज किसान साथी पोर्टल के माध्यम से पंजीयन शुल्क राशि रूपये 75,000/— प्रति आवेदक जमा करवायेगा। निर्माता द्वारा 3 वर्ष के ब्लॉक में किसी भी वित्तीय वर्ष में आवेदन करें, पंजीयन शुल्क राशि रू. 75,000/— ही होगी। पंजीयन शुल्क की वैधता वित्तीय वर्ष 2025—26 के अन्त तक ही मान्य होगी। उक्त राशि Non Refundable है।
- 5. पंजीयन शुल्क जमा करवाने के उपरांत पार्टल द्वारा पंजीयन प्रमाण पत्र का प्रारूप जनरेट होगा। सबंधित को निर्धारित अवधि में अमानत/सेक्योरिटी के रूप में राशि रू. 10.00 लाख की बैंक गांरटी आयुक्त कृषि, कृषि विभाग के पक्ष में कार्यालय में जमा करवानी होगी। बैंक गांरटी की वैधता अवधि 31 मार्च 2030 तक होगी। उक्त बैंक गारन्टी दिनांक 31.03.2030 के पश्चात् संबंधित को लौटा दी जावेंगी। वांछित दस्तावेज कार्यालय में प्राप्त होने के बाद पंजीयन प्रमाण पत्र जारी किया जाएगा।
- 6. पंजीकरण की वैधता वित्तीय वर्ष 2023—24 से 2025—26 के लिये ही मान्य होगी। पंजीकरण समाप्ति से पूर्व आगामी पंजीकरण की प्रक्रिया पूर्ण कर ली जावेगी। विशेष परिस्थितियों में पंजीकरण की अविध आपसी सहमित से अधिकतम 6 माह तक बढ़ाई जा सकती है।

8. पंजीकृत निर्माता अपने बी.आई.एस. लाईसेन्स की वैधता अवधि बढ़ाने हेतु आवेदन कार्यालय में प्रत्येक कार्य दिवस में प्रस्तुत कर सकेगा। प्रत्येक माह में दिनांक 25

तक प्राप्त आवेदनों की वैधता सूची एक साथ जारी की जावेगी।

TERMS AND CONDITIONS FOR REGISTRATION OF MANUFACTURER FIRMS FOR LINING OF FARM POND/ DIGGI WITH USE OF HDPE PLASTIC FILMS/POLYETHYLENE FILMS/ HDPE GEO MEMBRANE AT FARMER'S FIELD FOR THE FINANCIAL YEAR 2023-24 to 2025-26

(N.B.: Please read these instructions carefully before filling up the application form for Registration. Incomplete or deficient applications are liable to be rejected without giving any reason.)

Applications are invited from the manufacturers only for supply of 500 Micron or more ISI marked HDPE plastic films/Polyethylene films/ HDPE Geo membrane to the Cultivators / Farmers of Rajasthan. Applicant firm should be a manufacturer for HDPE plastic films/Polyethylene films/ HDPE Geo membrane and should have valid BIS license in his own name. It may be noted that this is not a Government purchase and it should also be noted that Dealer/ Sub dealer/ Trader / Unorganized sector shall not be registered.

Applications for registration shall be submitted online on Rajkisan Sathi Portal (https://rajkisan.rajasthan.gov.in)

The manufacturers seeking registration for lining of on farm Pond/ Diggi with use of HDPE plastic films/Polyethylene films/ HDPE Geo membrane at farmer's field during the financial year 2023-24 to 2025-26 (Three Years) are required to submit the following documents:-

- Certified copy of valid BIS Licenses
- 2. Application Fee of Rs 1000/- per Application will have to be deposited online. Only when found eligible in all respect, the firm will deposit a one time registration fee of Rs 75,000/- valid for block financial year 2023-24 to 2025-26 (Three Years) online on Rajkisan Sathi Portal. This registration fees is non-refundable.
- 3. Eligible firm has to submit Bank Guarantee in specified period, failing which registration fees will be forfeited.
- 4. Bank Guarantee of Rs 10.00 lac duly pledged in favour of Commissioner of Agriculture, Rajasthan, Jaipur valid up to 31.3.2030 for due performance of contract and supplies. Such Bank Guarantee, if invoked, shall be en-cashable at Jaipur.
- 5. A certified copy of application / registration of trademark from the competent authority in support of the brand for which the offer has been submitted. Only one brand will be approved for one manufacturing unit, however, HDPE plastic films/Polyethylene films/ HDPE Geo-membrane brand may be different for the same manufacturer.
- 6. The firms offering their rates will have to give the following undertakings on Rs 500/- Non Judicial Stamp paper:-

"We hereby undertake to assure that any manufacturing defect in HDPE plastic films/Polyethylene films/ HDPE Geo membrane will be replaced free of cost up to five years. We further undertake that the rate of particular brand of plastic films supplied will be same throughout the State.

If our firm fails to comply the same; the bank guarantee shall be forfeited fully. The firm will be liable to be blacklisted / deregistration and may not be registered in future for a period of five years".

- 7. The firm will have to furnish the copy of GST registration certificate.
- 8. The firm will have to furnish the list with full address of district-wise authorized agents / dealers in Rajasthan. Such a list will also be supplied to the concerned Joint Director, Agri. (Ext) of the district after registration.
- 9. The manufacturers have to produce their Internal Quality Assurance and Quality Control (QAQC) plan.
- 10. The manufacturers have to produce the ISO certificate (9000/9001/9002). The unit, which do not have the same, must get and submit the certificate within 6 months of registration.
- 11. The manufacturer will declare the MRP rate of plastic sheet for current year and that should not very within the state.
- 12. Physical verification report: latest electricity bill & photograph of running unit with date and time.

Other Terms & Conditions

- 13. Inspection of the factory may be done by the Departmental officials as and when felt necessary to ensure the performance and quality of the product,
- 14. A random sampling from the manufacturing unit or godown or authorized distributor/ dealer will be performed to ascertain the quality of supplies, if required.
- 15. In the event of any complaint regarding supply of defective/sub standard material, the manufacturer shall have to rectify the defects within a period of 15 days. If the firm fails to comply, the bank guarantee shall be forfeited fully. The firm will also be liable to be blacklisted and will not be registered in future for a period of five years.
- 16. The manufacturer should take the responsibility for any disputes arising from the supply of their product through their distributors or dealers.
- 17. Commissioner of Agriculture, Rajasthan, Jaipur reserves the right to reject/cancel the registration of manufacturers at any time if he is satisfied that it is desirable to do so in the interest of farmers of Rajasthan, after giving an opportunity of hearing to such manufacture. The decision of Commissioner of Agriculture, shall be final and binding.
- 18. For renewal of validity will be disposed by the registering authority once in the last week of the every month. The manufacturer is supposed to submit the

- renewed BIS license within a grace period of 2 months after the expiry of validity. The renewal process will be throughout the year, however in 1st lot application will be **April**, 2023.
- 19. The manufactures will have to compulsory imprint date of manufacture, Brand, C.M.L.No. on the HDPE plastic films/Polyethylene films/ HDPE Geo membrane supplied under subsidy scheme.
- 20. The manufacturers is aggrieved that any decision, action or omission of the registration Authority is in contravention to the provisions of the Act or the Rules or the guidelines issued thereunder, he may file an appeal to the first appellate Authority (PSA/ACS Agriculture) within a period of ten days from the date of such decision or action, omission, as the case may be, clearly, giving the specific ground or grounds on which he feels aggrieved.
- 21. Approval for registration will be subject to any other conditions from time to time, which may feel necessary to safeguard in the interest of farmers of Rajasthan.
